President. I practice as a licensed psychologist in this multidisciplinary private practice setting. Our group includes licensed psychiatrists, licensed doctoral psychologists, licensed advanced registered nurse practitioners, licensed master's level psychologists, licensed specialist clinical social workers, licensed clinical marriage and family therapists, substance abuse counselors and master's level associates. Clinical Associates, P.A. is an approved internship site and psychiatric nursing preceptorship site and my duties frequently include supervision of interns and post-doctoral fellows. While our group provides a full range of services to all ages, my practice is limited to evaluation and consultation. Clinical Associates, P.A. has multiple offices across Kansas and Missouri.

A main focus of my practice is evaluations. I provide forensic, diagnostic and selection/risk related evaluations. Consultations in these areas are also offered. Psychological evaluations are offered on both an outpatient basis as well as in facilities when needed. I provide drug and alcohol evaluations as well as mental health evaluations and sex offender evaluations to individuals who are under the jurisdiction of the United States Court Drug and Alcohol Treatment Services Program as well as to the U.S. Bureau of Prisons. Additionally, I provide sex offender and general psychological evaluations to detainees

associated with Immigration and Customs Enforcement. I provide services in the field of public safety including applicant and promotional assessment, fitness for duty related issues, consultation and training to various Federal, State and local agencies as well as private entities. I am currently a consultant for the Overland Park Police Department and provide services to a number of police departments in multiple states.

CA has provided the State of Kansas sex offender evaluations and treatment services both for incarcerated offenders and for offenders in the community on supervision throughout the state since 2010. We provide such services to adults and juveniles throughout the state (This was spun off to a separate entity, STAT Corporation, since 6-1-18). We provided sex offender related services to more select areas since 1992. CA provides similar services to Federal Probation and Parole as well as the Federal Bureau of Prisons. Additionally, CA has provided program design, consultation, evaluation and treatment services to the sexual predator transition program for the State of Kansas since 2000. CA provided the ChoicePoint program to Johnson County, Kansas serving juveniles in an intensive 24 week treatment program encompassing both detention/residential and outpatient services (outpatient only since 2015).
